# Copyrights in Islam and Pakistan: Ethical Perspectives and Legal Framework

## **Abstract**

While not explicitly addressed in classical Islamic jurisprudence, copyright in Islam finds its roots in the principles of intellectual property protection and fair exchange upheld by Islamic ethics. The Qur'an encourages respect for others' rights and forbids unjust appropriation. Islamic scholars interpret this to encompass intellectual property rights. The concept of 'ijtihad,' or independent legal reasoning, allows adaptation to modern contexts, including copyright law. Islamic history reveals protection for intellectual creations, such as scholars' attribution rights over their works. Contemporary Islamic legal scholars engage in discussions on copyright, emphasizing the protection of authors' rights and promoting creativity within Islamic ethical boundaries. While copyright law in Muslim-majority countries often aligns with international standards, some scholars advocate for a more comprehensive integration of Islamic principles into copyright legislation to ensure equitable protection for creators while fostering innovation and knowledge dissemination. This article contributes to the existing literature on intellectual property rights by providing a distinct perspective rooted in Islamic jurisprudence. It aims to acquire a more profound knowledge of the convergence of religion, law, and technology in shaping legal frameworks that promote creativity, innovation, and social welfare by investigating the concepts, applications, and current controversies surrounding copyrights in Islam.

#### Introduction

Intellectual property and copyright are becoming more pertinent in the digital age (World Intellectual Property Organization, 2023), where information flows freely, and creativity knows no limitations (Heine et al., 2023; Koshariya et al., 2023). However, amidst various legal systems and global conversations about copyright, the Islamic position provides a distinct and rich perspective on the subject (Laskowska-Litak, 2023). Copyright in Islam is based on centuries-old concepts and directed by Islamic jurisprudence. It entails many rights, duties, and ethical concerns (Calder, 2024).

Islamic jurisprudence profoundly embeds the fundamental ideals of justice and fairness, including intellectual property protection (Bently et al., 2022; Sark, 2023). The Qur'an and Hadith offer instructions on protecting individual rights and upholding property sanctity (Moussavi & Mavani, 2023). It should be borne in mind that for Muslims, Islamic Sharia is both a code of law and a code of morals to be adhered to (Coulson, 1969). Scholars have used principles from these sources to address contemporary challenges such as copyrights and intellectual property (Tutt & Harvey, 2022).

Conforming to the concept of 'haq' (right), 'milkiyya' (ownership), 'mal' (wealth), and 'manfa'a' (utility) (Jamar, 1992) were analyzed to clarify the position of copyright in Shariah law. The analysis of these crucial definitions shows that Shari'a approval is the most critical component in these concepts (Gendreau, 2023). Copyright is manfa'a and mal and can be owned (SRP, 2023). This understanding can provide enough room for copyright in Shari'a.

Based on solid evidence from *Shari'a*, well-established Islamic educational traditions emphasize the importance of honesty and demand that only the creator of a literary work be entitled to praise and honor (Alserhan et al., 2023). Undoubtedly, scientific honesty is long established, and its significance is widely acknowledged (Jankowska, 2023). However, no copyright was sought as it exists in its current form. Furthermore, under Islamic principles, plagiarism is religiously sinful, morally condemnable, and socially disreputable (An-Nabahani, 2002; Laskowska-Litak, 2023).





Scholars often hold three different perspectives on the issue of copyrights. Contrary to one opinion, the practice is Islamically allowed, and Muslims must respect the consequences of copyright laws (Gendreau, 2023). From early Islamic scholars' emphasis on attribution and respect for writers' rights to modern discussions on digital piracy and open access (Tutt & Harvey, 2022), the study of copyrights in Islam covers a wide range of themes that both religious and legal scholars find extremely meaningful.

After that, a view is upheld by the Majma Al-Fiqhi of the OIC and the Standing Committee of Religious Scholars of the Kingdom of Saudi Arabia (Sark, 2023). The opinion is that writing or inventing something is private and belongs to the individual. In today's contemporary world practices, there is material value to it that people can profit from (Vaid et al., 2023). These rights are to be respected from a Shariah perspective, and it is impermissible to transgress them.

## Research Justification

The intersection of intellectual property rights and religious principles presents a unique study area, particularly in countries where religion significantly shapes legal frameworks. Pakistan, as an Islamic republic, offers a compelling case for examining how Islamic ethical perspectives influence copyright laws. This research explores the confluence of Islamic principles and the Pakistani legal system regarding copyrights, providing a nuanced understanding of their coexistence and potential conflicts.

This research can illuminate the compatibility or tension between religious principles and modern legal requirements.

This analysis is essential for policymakers, legal practitioners, and scholars interested in harmonizing religious and legal standards.

Ethical Considerations: Investigating the ethical dimensions of copyrights in Islam provides a broader understanding of how intellectual property is perceived and protected within an Islamic context. It can contribute to the global discourse on intellectual property rights, emphasizing the diversity of ethical considerations across different cultural and religious landscapes.
- 4. **Practical Implications:** Insights from this research can inform the development of more culturally and religiously sensitive copyright policies in Pakistan. They can also enhance the effectiveness of intellectual property protection and encourage greater compliance among the populace.

#### Research Objectives

- I. To explore the ethical perspectives of Islam regarding intellectual property and how these are reflected in Pakistani legislation.
- 2. To identify potential conflicts and harmonization strategies between Islamic ethics and modern copyright laws.
- 3. To provide recommendations for policy enhancements based on the findings.

#### Research Methodology

This study employed a systematic review methodology, with research objectives established accordingly. A comprehensive literature review was conducted (Komba & Lwoga, 2020). Research findings were categorized based on their content (Hiver et al., 2021; Petticrew & Roberts, 2006), and classified information was incorporated into the study by organizing it into headings (Gan et al., 2021; Pawson et al., 2005). The evaluation of classified information and titles formed the basis of the study (Page, 2021; Rahi, 2017), ensuring the integrity of the research subject and its contents (Egger et al., 2022; Victor, 2008).

## Classification of Copyrights Infringement

#### I. Direct copyright infringement

It occurs when someone directly copies, distributes, or reproduces a copyrighted work without the owner's permission. Specifically, it violates the exclusive rights of the authorized copyright holder (Creative Media Partners, 2023). Examples of this infringement are:

- i. Copying and distributing a copyrighted book without permission.
- ii. Uploading and sharing copyrighted entertainment on the website.
- iii. Unlicensed public performance of a copyrighted composition.

## 2. Indirect copyright infringement

It is likewise referred to as collateral infringement, and it occurs when an individual helps or benefits from a direct violation without performing the act themselves (Tattay et al., 2023). In brief, indirect infringement refers to behaviors that either assist or profit from such violations. This infringement may include the following:





- i. Offering an accessible platform for unlawful file-sharing.
- ii. Selling a device that bypasses copyright protection measures.

Ilm Mustalah al-Hadith's literature is the basis of moral rights in the context of copyrights and intellectual honesty. For example, the institution of '*ijaza*' is particularly crucial to the protection of the moral rights of the original author (Sark, 2023). Contrary to that, Ibn Majah and At-Tirmidhi state that the Prophet's Hadith (peace be upon him) about wisdom being a lost property of the believer. However, this Hadith also implies that believers should be open-minded and learn from all sources (Moussavi & Mavani, 2023). They should be more concerned with what is said than who said it or where they received it. Ali (may Allah be pleased with him) claims to have stated, "Take wisdom, and it would not harm you from what bag it came."

This narration advocates for seeking knowledge from all sources, protecting property rights, and preventing theft and fraud, emphasizing the importance of preserving material and intellectual property. Another Hadith is "Whoever takes the property of others with a right to do so, he will carry it on the day of resurrection as if it were a donkey saddled on his back" (Sunan Ibn Majah 2440). This Hadith highlights the seriousness of taking someone's property without their permission.

## Fatawa from Sheikh Abd Al-Aziz Ibn Baz Regarding the Copyrights

- I. "Muslims should abide by their stipulations."
- 2. "A Muslim's property is not permitted (to be taken by others) without his consent."
- 3. "Whoever precedes others in gaining a Halal (lawful) thing will be more entitled to own it (than others)."

It is applicable whether the owner of this intellectual property is a Muslim or a non-Muslim (who is not at war with Muslims, for the property of the non-fighting unbelievers is to be protected in the same way as that of Muslims).

# Copyrights in Islam and the Current Scenario in Pakistan

While Pakistan's copyright laws are mainly secular, efforts have been made to harmonize them with Islamic beliefs. Fair use, moral rights, and exclusivity restrictions reflect Islamic justice and equity concepts. However, issues exist in aligning current laws with traditional Islamic norms, particularly in digital piracy, cultural assets, and access to knowledge. Pakistan has signed several international treaties and agreements protecting intellectual property rights, including copyright. Complying with these accords involves creating and executing copyright laws that align with international norms, regardless of religious convictions.

However, Islamic beliefs may influence or shape copyright laws in countries where Islam is deeply embedded in the legal system, such as Pakistan. While modern copyright laws are not explicitly based on Islamic principles, they are widely interpreted and used in the framework of Islamic ethics and values. Copyright laws in Pakistan, like in many other countries, protect creators' rights while simultaneously stimulating innovation, creativity, and economic progress. Pakistan's copyright laws support sectors including publishing, music, film, software development, and other creative fields by legally protecting intellectual property.

Pakistan has also been open to addressing the issue of IPRs and copyrights through State law, including the Copyrights Ordinance I962 and Copyrights Rules I967. The Karachi Copyrights Office was established in I963 and has been part of Pakistan's Intellectual Property Organization (IPO) since 2005. The Cabinet Division administers the Intellectual Property Organization. The IPO has actively sought helpful guidance from experts at the World Intellectual Property Organization (WIPO) and other friendly countries. In July 2006, IPO-Pakistan hosted an international workshop titled "WIPO National Workshop on Geographical Indications," with the aid of the EU and WIPO.

Lastly, we hope that future research and policy initiatives will focus on further integrating Islamic principles into copyright laws and practices in Pakistan. Collaboration between religious scholars, legal experts, and policymakers is crucial to addressing emerging challenges and opportunities in the digital age. By embracing Islamic ethics and values, Pakistan can establish a robust copyright regime that fosters creativity, innovation, and cultural exchange in harmony with its religious heritage. Pakistan still has a long way to go in this field.

## Discussion

The convergence of Islamic ethical perspectives and Pakistan's legal framework on copyrights presents a rich area for exploration. As a predominantly Muslim country, Pakistan's legal system is influenced by both secular laws and Islamic principles. This discussion delved into how these influences shape the approach to copyright protection in Pakistan, examining ethical considerations, legal structures, and practical implications.

#### Ethical Perspectives in Islam on Copyrights

I. Foundational principles: Islamic ethics emphasize justice, fairness, and protecting individual rights, which extend to intellectual creations. While not explicitly mentioning copyrights, the Qur'an and Hadiths advocate for respecting others' labor and creativity. Fundamental principles include *haqq al-mal* (the property right) and *haqq al-intifa'* (the





right to benefit from one's property), which can be interpreted to support intellectual property rights. In Arabic, *haqq* has two essential meanings: certainty and obligation (Kamali, 2003).

- 2. Moral and social responsibility: Islamic teachings stress the importance of benefiting the community and discouraging harm. This dual focus supports the idea that creators should be rewarded for their work, as it encourages further innovation and benefits society. However, there is also a moral imperative against monopolization and excessive restriction, which could impede knowledge dissemination and societal advancement.
- 3. Challenges and interpretations: Islamic scholars may differ in their interpretations of how *Sharia* (Islamic law) should be applied to modern intellectual property issues. Some might argue for a more conservative approach, while others advocate for a progressive understanding that accommodates contemporary realities.

#### Legal Framework in Pakistan

- 1. **Historical context and evolution:** Pakistan's copyright laws have evolved significantly since its independence in 1947. The primary legislation governing copyright is the Copyright Ordinance of 1962, which has been amended several times to address emerging issues and align with international standards. Furthermore, the Islamic Constitution of Pakistan 1973 has been drafted by Quranic teachings and, therefore, upholds private property rights, including tangible and intangible (Khan, 2021).
- 2. **Integration of Islamic principles:** The Pakistani legal system operates under a dual framework incorporating secular laws and Islamic jurisprudence. This integration is evident in various aspects of its legal code, including intellectual property laws.
- 3. **Pakistan as a signatory:** Pakistan is a signatory to various international treaties, including the Berne Convention and the TRIPS Agreement, which influence its domestic copyright laws.
- 4. **Judicial interpretations and case law:** Pakistani courts have addressed various copyright disputes, often considering statutory provisions and broader ethical principles. This judicial approach helps contextualize copyright protection within Pakistan's sociocultural and religious landscape.
- 5. **Need for harmonization:** Efforts to harmonize copyright laws with Islamic principles involve ensuring that laws comply with international standards and reflect the ethical values inherent in Islam.

This balance is crucial in a society that values religious traditions and modern innovation. Policies must navigate the tension between preventing unauthorized use and ensuring that restrictive measures do not stifle creativity and access to information.
- 2. **Public awareness and education:** Enhancing public awareness about copyright laws and their ethical underpinnings is essential. Many creators and users may need to fully understand their rights and obligations, leading to unintentional violations.
- 3. **Educational initiatives:** Educational initiatives should highlight the importance of respecting intellectual property as a legal and moral duty.
- 4. **Policy recommendations:** To address these challenges, it is recommended that Pakistan's copyright policies be continuously reviewed and updated to reflect both international developments and local ethical considerations.
- 5. **Strengthening enforcement:** Strengthening enforcement mechanisms, providing more precise guidelines for fair use, and fostering a culture of respect for intellectual property through education are crucial steps.

The interplay between Islamic ethics and Pakistan's legal framework on copyrights offers a unique perspective on intellectual property rights. By understanding and integrating these ethical principles, Pakistan can develop a more robust and culturally sensitive approach to copyright protection. This discussion underscores the need for ongoing dialogue and adaptation to ensure that copyright laws in Pakistan are both practical and reflective of the country's religious and cultural values.

#### Conclusion

In general, it is argued that industrial countries use copyright and intellectual property as an excuse to maintain their superiority and obstruct developing countries from economic growth or development. Nevertheless, we are living in the 21<sup>st</sup> century. Copyright infringement is a significant issue that affects the livelihoods of authors and publishers.
